Overview

The Private Pilot certificate has traditionally represented the first certification milestone in a pilot's journey. In recent years, the Recreational and Sport pilot certificates have been introduced to allow for certification with less aeronautical experience than that required for the Private Pilot. However, both alternatives impose significantly more limitations on the holder. For that reason, the Private Pilot certificate is still considered today to be the "gold standard" for most aspiring pilots.

As a Private Pilot - Airplane Single Engine Land, you will enjoy the ability to fly any single engine airplane with very few restrictions¹. You can operate to and from just about any airport, day or night, and fly within all types of controlled airspace in accordance with applicable regulations. You are free to take as many passengers as can be legally carried aboard the aircraft, and to travel as far as you want.

Prerequisites

To be eligible for enrollment in Avia's *61 Private Pilot - Airplane SEL course*, the candidate must

- Be able to read, speak, write and understand the English language
- If a US citizen, show proof of citizenship
- If not a US citizen, have received TSA clearance

While ground school and initial flight training may begin once the above prerequisites have been met, in order to operate an aircraft solo (without an instructor on board), the candidate must

- Be at least 16 years of age
- Hold at least a current and valid FAA Third Class medical certificate
- Hold a Student Pilot certificate
- Receive ground and flight training in all areas required by regulation
- Successfully complete a pre-solo written examination
- Be properly endorsed by an authorized instructor

Course Completion Requirements

To be eligible for course completion, the candidate must

- Be at least 17 years of age
- Hold at least a current and valid FAA Third Class medical certificate
- Satisfactorily complete all training required by the syllabus
- Pass an FAA aeronautical knowledge (written) exam
- Meet the following minimum time requirements (see 14CFR61.109)
 - 40 hours of flight time that includes
 - 20 hours of flight training that includes
 - 3 hours of cross-country flight training
 - 3 hours of night flight training that includes
 - One cross-country over 100 NM total distance
 - 10 takeoffs and full stop landings in the pattern
 - 3 hours of basic attitude instrument training
 - 10 hours of solo flight training
 - 5 hours of solo cross-country flight
 - One solo cross-country of at least 150 NM with stops at a minimum of 3 points (one segment must be at least 50 NM)
 - 3 takeoffs and full-stop landings at a towered airport
